2. **Secure Document Storage:** If you must write it down, store it in a secure location at home, such as a locked filing cabinet, separate from other important documents.
3. **Avoid Sharing Unnecessarily:** Only provide your TFN to trusted individuals or organisations that genuinely require it, such as your employer, the ATO, your superannuation fund, or financial institutions.
4. **Be Wary of Scams:** The ATO will never ask for your TFN via email, SMS, or social media. Be suspicious of any unsolicited requests. If you receive a suspicious communication, contact the ATO directly.
