1. **Accuracy:** Ensures the calculated amount is based on accurate financial information, preventing under- or over-payment.
2. **Legal Compliance:** Adheres to North Carolina's child support laws and guidelines.
3. **Fairness:** Aims to provide a fair and reasonable distribution of financial responsibility between parents.
4. **Transparency:** Offers a clear and understandable process for parents to see how their support obligation is determined.
5. **Foundation for Agreements:** Serves as the basis for out-of-court settlement agreements or court-ordered support.

Key Components of NC Child Support Calculator Worksheet B

Worksheet B is structured in a way that systematically gathers and processes information to arrive at the final support amount. While the exact layout may have minor variations, the core components remain consistent. Parents will typically need to gather information for the following sections:

1. Identifying Information

This initial section is straightforward, requiring details about the parties involved, including:

1. Full names of both parents (custodial and non-custodial).
2. Names and dates of birth of the children for whom support is being calculated.
3. Case number and court information.

2. Gross Income Determination

This is arguably the most critical section, as it forms the foundation of the calculation. Parents must accurately report their monthly gross income from all sources. This includes:

1. **Wages, Salary, Commissions, Bonuses, and Tips:** This is income before taxes and other deductions. It's important to report the full amount earned.
2. **Self-Employment Income:** For those who are self-employed, this is typically calculated as gross receipts minus ordinary and necessary business expenses. The net income from self-employment is then used.
3. **Investment Income:** This can include dividends, interest, capital gains, and other income derived

from investments.

4. **Pension and Annuity Income:** Payments received from retirement plans or annuities.
5. **Unemployment Benefits:** Income received from unemployment compensation.
6. **Workers' Compensation Benefits:** Payments received due to work-related injuries.
7. **Disability Benefits:** Income received from short-term or long-term disability.
8. **Social Security Benefits:** If the parent receives benefits, this needs to be reported.
9. **Other Income Sources:** Any other regular and recurring income not specifically listed above.

Important Note: The guidelines generally look at income from the past 12 months to establish a consistent average, particularly for those with variable income.

3. Adjustments to Income

Certain deductions are allowed to arrive at the "Adjusted Gross Income" (AGI) which is then used in the calculation. These are specific and not every deduction from a tax return is applicable. Common adjustments include:

1. **Actual Amount Paid for Other Child Support:** If a parent is obligated to pay child support for children from another relationship, this amount can be deducted.
2. **Actual Amount Paid for Spousal Support:** Similarly, payments for spousal support (alimony) to a former spouse can be deducted.
3. **Deductible Portion of Self-Employment Taxes:** For self-employed individuals, a portion of the self-employment taxes paid is deductible.
4. **Social Security Taxes Paid:** The portion of Social Security taxes paid by the employee.
5. **Medicare Taxes Paid:** The portion of Medicare taxes paid by the employee.
6. **Contributions to Retirement Plans:** Mandatory contributions to retirement plans like 401(k)s or pensions, up to a certain limit, can sometimes be deducted if they are a condition of employment.
7. **Union Dues:** Mandatory union dues paid by the parent.

The calculation then determines the "Total Adjusted Gross Income" of both parents, which is crucial for the next step.

4. Determining Parenting Time and Custody Arrangements

This section addresses how much time each parent spends with the children. North Carolina child support law distinguishes between custodial and non-custodial parents. Worksheet B often accounts for variations in overnight stays. The percentage of overnight stays is a significant factor in determining the final support order, especially in shared parenting scenarios.

5. Calculating the Basic Child Support Obligation

Using the combined adjusted gross income of both parents and the number of children, a "Basic Child Support Obligation" is determined. This is derived from a table within the North Carolina Child Support Guidelines. The table provides a presumptive amount based on income and child count.

6. Allocating the Basic Child Support Obligation

The Basic Child Support Obligation is then allocated between the parents based on their respective pro-rata shares of the combined adjusted gross income. For example, if one parent earns 70% of the combined income, they will be responsible for 70% of the Basic Child Support Obligation.

7. Adjustments for Parenting Time (Worksheet B Specifics)

This is where Worksheet B truly shines in reflecting the reality of shared parenting. Unlike simpler calculations, Worksheet B makes specific adjustments for the amount of time the non-custodial parent spends with the children. If the non-custodial parent has a significant amount of overnight stays (typically more than 123 overnights per year), the support obligation is adjusted downward to reflect the costs incurred by that parent during their parenting time. The exact adjustment is calculated based on a formula within the guidelines that considers the number of overnights.

8. Extraordinary Medical Expenses

The cost of unreimbursed medical, dental, and vision expenses for the children is also addressed. Typically, these expenses are divided proportionally between the parents based on their adjusted gross incomes. Worksheet B will include a section to document these costs and how they are to be shared.

9. Childcare Expenses

Necessary childcare expenses incurred by the custodial parent due to employment or job search are also factored in. These expenses are usually divided proportionally between the parents, similar to extraordinary medical expenses. Worksheet B will require documentation of these costs.

10. Health Insurance Premiums

The cost of health insurance premiums for the children is considered. The parent providing the health insurance coverage may receive a credit or adjustment to their support obligation. The premium amount attributable to the children is usually divided proportionally.

11. Other Expenses

Depending on the specific circumstances, other expenses may be considered, such as educational expenses for gifted or special needs children, or transportation costs related to visitation. These are often discretionary and require specific court approval.

12. Final Child Support Amount

After all adjustments for parenting time, extraordinary medical expenses, childcare, health insurance, and any other applicable factors, the final child support amount is determined. This is the amount that the non-custodial parent will typically be ordered to pay to the custodial parent.

Common Challenges and Considerations When Using Worksheet B

While Worksheet B aims for clarity, several challenges can arise:

1. Income Verification and Disputes

Disputes over income are common. Parents may misrepresent their income, fail to disclose all sources, or have complex self-employment income. Accurate documentation (pay stubs, tax returns, bank statements) is crucial. If a parent is unemployed or underemployed, the court may impute income based on their earning capacity. This means they calculate support as if the parent were earning what they reasonably *could* earn.

2. Self-Employment Income Complexity

Calculating income for the self-employed is significantly more complex than for W-2 employees. It requires careful review of business expenses and profit and loss statements. Consulting with an accountant or legal professional can be invaluable in these situations.

3. Determining "Extraordinary" Expenses

What constitutes an "extraordinary" medical or educational expense can be subjective. Parents should be prepared to provide documentation and justification for these costs. The court will make the final determination.

4. Parenting Time Disputes

Inaccurate reporting of parenting time can significantly impact the support calculation. Clear and consistent documentation of overnight stays is essential. Disputes over custody arrangements can delay the finalization of support orders.

5. Deviating from Guidelines

While the North Carolina Child Support Guidelines are presumed to be in the best interest of the child, courts can deviate from them under certain circumstances. This typically requires a showing of good cause and that deviating from the guidelines is necessary to meet the best interests of the child. Examples include a child with special needs requiring extensive care or a significant disparity in parental incomes and lifestyles.

Tips for Parents Completing Worksheet B

1. **Be Thorough and Honest:** Accurately report all income and expenses. Inaccuracies can lead to legal complications.
2. **Gather All Documentation:** Collect pay stubs, tax returns, bank statements, receipts for medical and childcare expenses, and any other relevant financial documents.
3. **Understand the Definitions:** Familiarize yourself with terms like "gross income," "adjusted gross

income," and "pro-rata share."

4. **Seek Professional Help:** If you have complex financial situations, significant income fluctuations, or are unsure about any part of the process, consult with a family law attorney or a child support enforcement agency.
5. **Use the Official Forms:** Always use the most current version of Worksheet B provided by the North Carolina courts or the Division of Child Support Services.
6. **Don't Estimate:** Use actual figures supported by documentation whenever possible.

Worksheet B vs. Worksheet A

It's important to note that North Carolina also uses **Worksheet A** for child support calculations. Worksheet A is generally used in cases where one parent has primary physical custody and the other parent has minimal overnight visits (less than 123 overnights per year). Worksheet B is specifically designed for situations where there is shared or split parenting, with the non-custodial parent having a more significant role and time with the children. The primary difference lies in how parenting time is factored into the calculation, with Worksheet B making substantial adjustments for the non-custodial parent's expenses during their custody periods.
