5. Outcome and Follow-up

The ombudsman will communicate its decision to both parties. If the complainant accepts the decision, the matter is closed. If the organisation fails to comply with a recommendation, the ombudsman has powers to name and shame them and can also seek further legal remedies in some cases. This ensures that the ombudsman's decisions have real teeth.
