The Admiralty Court in Gibraltar, where the ship was brought, found no evidence of wrongdoing by the crew of the *Dei Gratia* and awarded them salvage fees. However, the court's findings did not solve the fundamental question of what happened to the missing individuals.

The tale of the **Mary Celeste** has transcended mere historical curiosity. It has become a potent symbol of the unknown and the terrifying possibilities that lurk in the vast expanse of the ocean. It has inspired countless books, articles, films, and even a board game. The name "Mary Celeste" itself has become synonymous with an unexplained disappearance at sea.

The absence of a definitive answer is, perhaps, what makes the **Mary Celeste** so compelling. It challenges our need for closure and forces us to confront the limits of our knowledge. The ship, a silent sentinel of the sea, continues to sail through our imaginations, a perpetual enigma, its story a chilling reminder of the ocean's unfathomable depths and its enduring capacity for mystery.

While the exact circumstances of the **Mary Celeste's** abandonment may forever remain lost to the waves, the legend of this ghost ship continues to sail on, a testament to the enduring power of unsolved mysteries.
