The fall of the Berlin Wall and the collapse of the Soviet Union led many to declare the "end of history" and the triumph of liberal capitalism. However, Eagleton argues that this narrative was premature and superficial. The underlying contradictions of capitalism, which Marx so brilliantly articulated, have not disappeared. Instead, they have mutated and manifested in new ways. The increasing precarity of work, the environmental crisis driven by unchecked industrialization, and the growing influence of corporate power in politics are all issues that resonate with Marxist concerns.

Eagleton's ongoing engagement with Marxist theory is a testament to its enduring power as a critical lens. He believes that by understanding the historical and material forces that shape our lives, we can begin to challenge them. His work encourages us to look beyond the surface-level explanations of societal problems and to question the underlying power structures that perpetuate inequality and exploitation. In this sense, Terry Eagleton argues that Marx was right, not in his every prediction, but in his fundamental

diagnosis of the human condition under capitalism and in his provision of the most potent tools for its critique.

The continued relevance of Marxism, as championed by Eagleton, lies in its capacity to foster critical thinking and to inspire a desire for a more just and equitable world. While the specific historical circumstances of Marx's time may have passed, the fundamental dynamics of power, exploitation, and alienation that he identified continue to shape our contemporary lives. Eagleton's work serves as a vital reminder that the critique of capitalism, pioneered by Marx, remains an essential intellectual endeavor for anyone seeking to understand and transform the world around them. The ongoing debates about **socialism vs. capitalism**, wealth distribution, and the future of work all benefit from a robust engagement with Marxist ideas, and Terry Eagleton's thoughtful interventions are at the forefront of this crucial intellectual revival.
