Selecting the Appropriate Contract Type

The contract type governs the financial and legal relationship between the client and the contractor.

4. **Design and Build Contracts:** These contracts integrate the design and construction elements, with the contractor responsible for both.

The choice of procurement route and contract type is

heavily influenced by factors such as project complexity, the client's risk appetite, the need for speed, and the availability of design information. A well-matched strategy is crucial for successful project outcomes and cost management.

3. Tender Preparation and Prequalification

Once the strategy is set, the next step is to prepare for the tendering process.

Prequalification of Bidders

Before inviting tenders, clients often prequalify potential contractors. This involves assessing their financial stability, technical capabilities, past performance, and health and safety record. Prequalification ensures that only competent and capable organizations are invited to submit tenders, saving time and resources for both the client and the bidders. This is a vital step in risk mitigation.

Tender Document Preparation

This involves compiling all the necessary documentation that prospective bidders will use to prepare their proposals. This typically includes:

4. Tender Evaluation and Award

This stage involves receiving, reviewing, and assessing the tenders submitted by prospective contractors.

The Evaluation Process

Awarding the Contract

Once the evaluation is complete, the contract is awarded to the most advantageous tenderer. This decision should be based on the pre-defined evaluation criteria, ensuring fairness and transparency. The client then formally notifies the

successful bidder and commences contract finalization.

5. Contract Administration and Management

The procurement process doesn't end with contract award. Effective contract administration is crucial for the successful execution of the project.

1. **Contract Execution:** Formalizing the agreement through signing the contract.
2. **Site Mobilization:** The contractor preparing to commence work on-site.

necessary approvals.

6. **Dispute Resolution:** Having mechanisms in place to address and resolve any disagreements or disputes that may arise between the client and the contractor.
7. **Quality Assurance and Control:** Ensuring that the construction work meets the specified quality standards through regular inspections and testing.
8. **Risk Management:** Continuously identifying, assessing, and mitigating potential risks throughout the project lifecycle.
9. **Health and Safety Management:** Ensuring compliance with all health and safety regulations on site.

This ongoing management phase is where the success or failure of the project is often determined. Proactive contract administration minimizes risks and ensures that the project stays on track.

6. Project Close-out and Handover

The final stage involves the formal completion and handover of the project.

1. **Practical Completion:** The point at which the building is substantially complete and ready for occupation, although minor defects may still exist.

2. **Defects Liability Period:** A period after practical completion during which the contractor is responsible for rectifying any defects that appear.
3. **Final Account Settlement:** Agreeing on the final costs of the project, including any variations or claims.
4. **Handover of Documentation:** Providing the client with all relevant project documentation, including as-built drawings, operation and maintenance manuals, and warranties.
5. **Post-Occupancy Evaluation:** Assessing the performance of the building after occupation to identify lessons learned for future projects.

A thorough close-out ensures all contractual obligations are met and provides the client with a fully functional building and all necessary supporting documentation.
