An 8-bit ADC can represent  $2^8$  (256) distinct values, while a 16-bit ADC can represent  $2^{16}$  (65,536) values. A higher bit depth allows for finer quantization

of the analog signal, leading to higher resolution in the digital output.

**Quantization error** is an inherent limitation introduced by the ADC. It's the difference between the actual analog value and the closest digital representation. The resolution of the ADC directly impacts the magnitude of this quantization error. A higher resolution ADC results in smaller quantization errors.

### 3. Display and Output Capabilities
