3. **Storage:** Solid-State Drives (SSDs) are significantly faster than traditional Hard Disk Drives (HDDs) and will dramatically improve the performance of your virtual machines. A sufficient amount of storage (e.g., 500GB or 1TB SSD) will be needed for operating system installations and virtual machine files.
4. **Network Adapter:** A Gigabit Ethernet adapter is standard and sufficient for most lab environments.

Software Requirements

You'll need virtualization software and the operating systems to install within your virtual machines.

1. **Virtualization Software:** Several options are available, both free and commercial.
 1. **VMware Workstation Player/Pro:** A popular choice offering robust features. Player is free for non-commercial use.
 2. **Oracle VM VirtualBox:** A completely free and open-source hypervisor, excellent for beginners and home labs.
 3. **Microsoft Hyper-V:** Built into Windows Pro and Enterprise editions, it's a powerful native hypervisor. For this guide, we will assume the use of VirtualBox or Hyper-V due to their accessibility.
2. **Windows Server Operating System:** You will need an ISO image of a Windows Server version. Windows Server 2016, 2019, or 2022 are current and excellent choices for an AD DS lab. Microsoft offers evaluation versions for free download, which are perfect for lab use.
3. **Windows Client Operating System:** To simulate a network environment, you'll want at least one Windows client machine (e.g., Windows 10 or Windows 11). Again, evaluation versions are readily available.

Setting Up Your Virtual Environment

With your hardware and software in place, it's time to build the foundation of your AD DS lab.

Step 1: Install Virtualization Software

Download and install your chosen virtualization software (VirtualBox, VMware Player, or ensure Hyper-V is enabled in Windows). Follow the on-screen instructions for a standard installation.

Step 2: Create a Virtual Network

A crucial step for any network lab is to configure a virtual network. This allows your virtual machines to communicate with each other and with your host machine if needed. Most hypervisors offer different network modes:

1. **NAT (Network Address Translation):** Allows VMs to access the internet through the host machine's IP address. Each VM gets a private IP address within the virtual network.
2. **Bridged Adapter:** Connects VMs directly to your physical network, assigning them IP addresses from your router's DHCP server. This is often the easiest for simple labs.
3. **Host-Only Adapter:** Creates a private network between your host machine and the VMs. VMs can communicate with each other and the host, but not the external network.
4. **Internal Network:** Creates a network solely for VMs, isolated from the host.

For an AD DS lab, a **Bridged Adapter** or a dedicated **Internal Network** configured with your own virtual router/DHCP server is often preferred. For simplicity, let's assume a Bridged Adapter for now. You can create a new virtual network in your hypervisor's settings and assign it to your upcoming virtual machines.

Step 3: Install Windows Server (Domain Controller)

Now, you'll create your first virtual machine and install Windows Server.

1. **Create a New Virtual Machine:** In your virtualization software, create a new VM. Allocate sufficient RAM (e.g., 4GB for a DC) and disk space (e.g., 60GB minimum).
2. **Configure Network Adapter:** Ensure the VM's network adapter is configured to use the virtual network you created earlier (e.g., Bridged Adapter).
3. **Install Windows Server:** Mount the Windows Server ISO image to the VM's virtual DVD drive and start the VM. Follow the standard Windows Server installation process.
4. **Initial Configuration:** After installation, it's good practice to assign a static IP address to your server. Navigate to Network Connections, select your adapter, go to Properties, and configure IPv4 settings. Choose an IP address that falls within your virtual network's subnet and set a valid subnet mask and gateway (if applicable). Configure your DNS server to point to itself (e.g., 127.0.0.1) later during the AD DS installation.
5. **Name Your Server:** Give your server a descriptive name (e.g., DC01).

Step 4: Install Windows Client (Optional but Recommended)

Create a second VM and install your chosen Windows client OS (Windows 10/11). Again, allocate adequate resources (e.g., 4GB RAM, 40GB disk space) and configure its network adapter to use the same virtual network as your server.

Installing and Configuring Active Directory Domain Services

This is the core of your lab setup. Once your Windows Server VM is installed, configured with a static IP, and named, you're ready to make it a domain controller.

Step 1: Add the Active Directory Domain Services Role

On your Windows Server VM:

1. Open **Server Manager**.
2. Click **Manage > Add Roles and Features**.
3. In the wizard, click **Next** until you reach the **Server Roles** page.
4. Select **Active Directory Domain Services**.
5. When prompted to add required features, click **Add Features**.
6. Click **Next** through the remaining pages and click **Install**.

Step 2: Promote the Server to a Domain Controller

After the role installation is complete, a notification flag will appear in Server Manager. Click on it and select **"Promote this server to a domain controller."**

The Active Directory Domain Services Configuration Wizard will launch. This is where you'll make critical decisions about your domain.

1. **Deployment Operation:** For a new lab, select **"Add a new forest."**
2. **Root Domain Name:** Choose a domain name. For a lab environment, it's common to use a non-routable domain name like `yourlab.local` or `ad.local`. Avoid using real internet domain names that you own to prevent DNS conflicts.
3. **Domain Controller Options:**
 1. **Forest Functional Level:** Choose the highest level supported by your Windows Server version (e.g.,

Windows Server 2016 or higher). This enables all available AD features.

2. **Domain Functional Level:** Similar to the forest functional level.
3. **DNS Server:** Ensure the "Domain Name System (DNS) server" checkbox is selected.
4. **Global Catalog (GC):** This should also be selected for the first DC.
5. **Read-Only Domain Controller (RODC):** Leave unchecked for your primary DC.
4. **DSRM Password:** Set a strong password for the Directory Services Restore Mode. This is critical for disaster recovery.
5. **DNS Options:** You'll likely see a warning about DNS delegation. For a lab, this is usually ignorable.
6. **Paths:** Accept the default paths for the AD DS database, log files, and SYSVOL unless you have specific reasons to change them.
7. **Review Options and Install:** Review your selections and click **Install**. The server will automatically reboot once the promotion process is complete.

Once the server restarts, it will be a domain controller for your newly created domain.

Post-Installation Tasks and Essential Configurations

Your AD DS lab is now functional, but there are essential next steps to make it robust and useful.

Step 1: Join Client Machines to the Domain

On your Windows client VM:

1. Ensure the client VM is on the same virtual network and has a valid IP address and DNS configured to point to your domain controller's IP address.
2. Go to System Properties (right-click Start > System).
3. Under "Computer name, domain, and workgroup settings," click "Change settings."
4. In the System Properties window, click "Change..."
5. Under "Member of," select "Domain" and enter your domain name (e.g., `yourlab.local`).
6. Click **OK**. You will be prompted for domain administrator credentials (e.g., `YOURDOMAIN\Administrator` and its password).
7. Restart the client machine.

Your client machine is now part of your AD DS domain.

Step 2: Explore Group Policy Management

Group Policy Objects (GPOs) are a cornerstone of AD DS management. They allow you to enforce configurations and settings across your domain.

1. On your domain controller, open **Group Policy Management** from Server Manager.
2. You'll see your domain listed. Right-click on your domain and select "Create a GPO in this domain, and Link it here..."
3. Give your GPO a descriptive name (e.g., "Password Policy").
4. Edit the GPO and navigate through the structure to configure settings like password complexity, account lockout policies, software deployment, desktop restrictions, etc.
5. Use `gpupdate /force` on client machines to apply the new policies immediately.

Step 3: Create Organizational Units (OUs) and Users

Instead of placing all users and computers directly under the default "Users" and "Computers" containers, it's best practice to create OUs to organize your AD objects hierarchically.

1. Open **Active Directory Users and Computers**.
2. Right-click on your domain and select "New" > "Organizational Unit." Create OUs for departments, locations, or computer types.
3. Right-click within an OU and select "New" > "User" to create new user accounts.
4. Configure user properties, group memberships, and home folders.

Step 4: Understand DNS Integration

Active Directory heavily relies on DNS for name resolution. Ensure your domain controller is also acting as a DNS server for your lab. Verify that your client machines are configured to use the DC's IP as their primary DNS server. Check the DNS zone for your domain in the DNS Manager tool to see SRV records that AD DS automatically registers.

Advanced Topics and Next Steps

Once you're comfortable with the basics, your AD DS lab is the perfect playground for exploring more advanced concepts:

1. **Domain Trusts:** Set up trust relationships between multiple domains or forests.
2. **Active Directory Certificate Services (AD CS):** Implement a public key infrastructure (PKI) for secure communication and authentication.
3. **File and Print Services:** Configure shared folders and printers with AD DS permissions.
4. **Exchange Server Deployment:** Integrate Microsoft Exchange Server for email services.
5. **PowerShell Scripting:** Automate repetitive AD management tasks.
6. **Azure AD Connect:** Explore hybrid identity by synchronizing your on-premises AD with Azure Active Directory.
7. **Disaster Recovery:** Practice AD restore procedures using the DSRM password.
8. **Security Hardening:** Implement advanced security configurations and audit policies.
