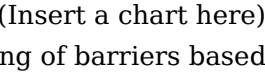

3. Reliance on echolalia (repeating what is heard) rather than independent labeling.

A weak tact repertoire can lead to a limited understanding of the world and difficulty in engaging in meaningful conversations where descriptive language is required. It hinders a child's ability to share their experiences and observations.

4. Listener Responding (Receptive Language)

Listener responding, or receptive language, is the ability to understand spoken language and follow instructions. Barriers in this area include:

1. Difficulty following simple directions (e.g., "give me the ball").
2. Not responding when their name is called.
3. Trouble identifying objects or pictures when named.

Weak receptive language can make learning and social interaction extremely challenging. A child who doesn't

understand instructions may appear defiant or inattentive, when in reality, they lack the comprehension to respond appropriately.

5. Intraverbal Repertoires

Intraverbals are crucial for social interaction, storytelling, and higher-level cognitive functions. Their absence significantly limits a child's ability to engage in meaningful dialogue and express complex thoughts.

6. Automatic Speech

Automatic speech refers to vocalizations that occur without conscious effort, such as singing songs or reciting nursery rhymes. While not a primary communication skill, it can be an indicator of verbal development. Barriers might involve:

1. Lack of spontaneous singing or reciting learned phrases.
2. Difficulty with rote memory for verbal sequences.

This area can sometimes be a gateway to more complex verbal skills, and its absence can be a subtle indicator of broader challenges.

7. Programing Generalization

Generalization is the ability to apply learned skills in new environments, with new people, or with slight variations of the original learning conditions. A barrier here means:

1. A child can only perform a skill in the therapy room with a specific therapist.
2. Difficulty using learned words or phrases in different contexts.
3. Reliance on prompts that are specific to the initial learning setting.

This is a critical barrier because it limits the practical application of learned skills in everyday life, hindering functional communication and independence.

8. Programing Maintenance

Maintenance is the ability to retain learned skills over time without constant re-teaching. Challenges in maintenance indicate:

1. Skills are quickly forgotten after they are taught.
2. Frequent need for repeated instruction to perform a previously learned skill.

Lack of maintenance suggests that the learning is not deeply entrenched, and ongoing strategies are needed to solidify the

skill.

9. Unwanted Behaviors

The VB-MAP Barriers Assessment also considers behaviors that interfere with learning and communication, such as:

1. Self-stimulatory behaviors (stimming) that are disruptive.
2. Aggression or tantrums that prevent learning opportunities.
3. Avoidance behaviors that hinder engagement.
