This practical experience with diverse languages, particularly those of indigenous peoples, fostered a keen awareness of the limitations of existing linguistic models and a desire for a more robust, empirically grounded approach.

His early publications, often appearing in journals like *Language* and *International Journal of American Linguistics*, showcased his meticulous observational skills and his emerging theoretical framework. Key to this period is the development of his seminal theory: **tagmemics**. This approach, which views language as a hierarchical structure of units called tagmemes, revolutionized how linguists analyzed sentence structure and grammatical relationships.
